Exposure assessment: Exposures are dependent on the product being handled, the potential for chemical release, and any resulting airborne concentrations or dermal contact. 8.2.2 Personal protective equipment

- Eye/face protection : Use safety goggles tested according to EN 166/ ANSI Z87.1 or equivalent local standard.
