8.2 Exposure controls

Exposure assessment: Exposures are dependent on the product being handled, the potential for chemical release, and any resulting airborne concentrations or dermal contact. Since product handling and release scenarios vary, and no two workplaces are exactly alike, it is recommended that the potential for exposure be assessed prior to the product's use or introduction. Exposure assessments should be performed by an occupational hygienist, industrial hygienist, or other qualified occupational or environmental health professional. Use engineering controls to maintain airborne levels below exposure limit requirements or guidelines. If there are no applicable exposure limit requirements or guidelines, use the product only with adequate ventilation.

8.2.2 Personal protective equipment

- Eye/face protection : Use safety goggles and faceshield tested according to EN 166/ ANSI Z87.1 or equivalent local standard.
- Hand protection : Use gloves when handling substance in open systems. Inspect gloves prior to use. Train operators for proper use.
